

FOWLER, Their Heirs & Assigns, Forever:

ALL that piece, parcel or lot of land, with improvements thereon, located in the County of Greenville, State of South Carolina, and situate, lying and being on the southern side of Churchill Circle at its intersection with Hull Drive, and being known and designated as Lot No. 98 on a plat of Portion of Augusta Acres, dated March, 1956, by Dalton & Neves, recorded in the RMC Office for Greenville County in Plat Book P, at page 25, and has according to said plat the following metes and bounds, to wit:

BEGINNING at a point on the southern side of Churchill Circle, joint front corner of Lots Nos. 98 and 99 and running thence along the line of Lots Nos. 98 and 99, S. 15-45 E. 136 feet to a point; thence running S. 69-42 W. 82.5 feet to a point on the eastern side of Hull Drive; thence running along Hull Drive, N. 20-18 W. 216.2 feet to a point; thence around the curve of Hull Drive at its intersection with Churchill Circle, the chord of which is N. 26-59 E. 36.7 feet to a point on Churchill Circle; thence following Churchill Circle N. 74-15 E. 74.1 feet to the point of beginning.
