KNOW ALL MEN BY THESE PRESENTS, that We, C. S. MATTOX and WILSON M. DILLARD,

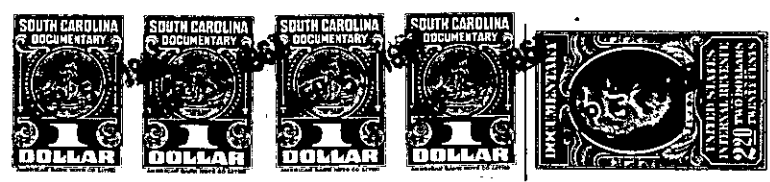
in consideration of One Thousand Nine Hundred and No/100 (\$1,900.00)----- Dollars,
