the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto ROBERT W. EDWARDS, his heirs and assigns forever,

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying, and being on Holly Road and being known and designated as Lot No. 3 on a plat of EDWARDS FOREST HEIGHTS as shown on plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 000, at page 87, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 3 and 4, N. 38-07 W. 175 feet to an iron pin at the joint rear corner of said lots; thence along the rear line of Lot 3 S. 51-53 W. 110 feet to an iron pin at the rear corner of Lots 2 and 3; thence with the joint line of said lots S. 38-07 E. 175 feet to an iron pin at the joint front corner of said lots on Holly Road; thence with Holly Road N. 51-53 E. 110 feet to an iron pin, the point of beginning.
