KNOW ALL MEN BY THESE PRESENTS, that we, Phillip D. Sanders, Jess Gillespie and Zola McCarter, as Trustees for Faith Tabernacle,

in consideration of One and No/100 (\$1.00) ----- Dollars

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Faith Tabernacle, Inc., its successors and assigns forever:

All those pieces, parcels or lots of land situate in Greenville County, State of South Carolina, on the southern side of Union Street, and being known and designated as Lots Nos. 103, 104 and 105 of Donwood as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "A", at Page 462, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Union Street at the joint front corner of Lots Nos. 105 and 106 and running thence along the joint line of said lots S. 15-20 E. 150 feet to an iron pin; thence S. 74-26 W. 150 feet to an iron pin; thence along the joint line of Lots Nos. 102 and 103 N. 15-20 W. 150 feet to an iron pin on the south side of Union Street; thence along said Street N. 74-26 E. 150 feet to the point of beginning. LESS HOWEVER that portion of Lot No. 103 conveyed to the Railroad in Deed Book 11, at Page 439.

The above is the same property conveyed to the grantors by deed recorded in Deed Book 772, at Page 186. ALSO see deed recorded in Deed Book 773, at Page 426.
