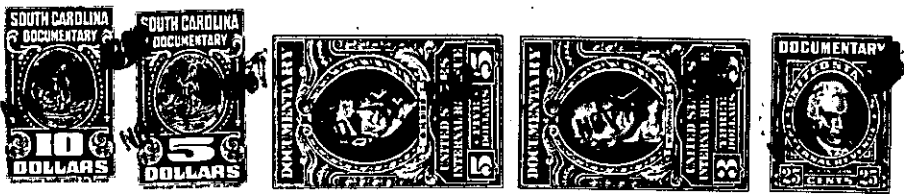
McCALL CONSTRUCTION CO., INC., ITS SUCCESSORS AND ASSIGNS, FOREVER:
