

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being on the western side of West Dorchester Boulevard, being known and designated as Lot 162 on a plat of Belle Meade Subdivision, said plat being recorded in Plat Book GG, Page 95, R. M. C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:
