LOT 3: BEGINNING at an iron pin on the northern side of Wood Heights Avenue at the joint front corner of Lots Nos. 4 and 3 and running thence N. 37-38 E. 95 feet to an iron pin; thence N. 49-09 W. 200.32 feet to an iron pin; thence S. 37-38 W. 90 feet to an iron pin; thence S. 47-43 W. 200.7 feet to an iron pin, the point of beginning.

LOT 4: BEGINNING at an iron pin on the northern side of Wood Heights Avenue at the joint front corner of Lots 3 and 4 and running thence N. 47-43 W. 200.7 feet to an iron pin; thence S. 37-38 W. 90 feet to an iron pin on the eastern side of a fifty foot road; thence along said road S. 46-18 E. 201.1 feet to an iron pin; thence along the northern side of Wood Heights Avenue N. 37-38 E. 95 feet to the point of beginning.
