Received of the SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY ONE \$00 /100 Dollars in consideration of which (I) (We) hereby grant said Company, its associated and allied companies, their respective licensees, successors and assigns, the right to construct, operate and maintain a line of communication consisting of such poles, wires, cables, conduits, guys, anchors and other necessary appurtenances as from time to time are required upon, across, over and/or under that certain tract of land situated in GREENVILLE County, State of SOUTH CAROLINA, to-wit:

THAT PROPERTY BOUNDED ON THE NORTH BY PROPERTY OF T.M. CRAIN AND ON THE SOUTH BY PROPERTY OF MRS LESIE BOMAR, AND ON THE EAST BY S.C. HWY. NO. 101
