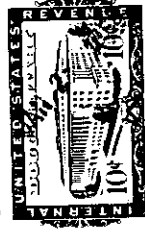
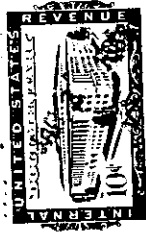

KNOW ALL MEN BY THESE PRESENTS, That We, LEWIS ANSEL MILES and RUTH M. PATRICK, AS TRUSTEE FOR ETHEL CORNELIA MILES

in the State aforesaid, in consideration of the sum of Seven Thousand Six Hundred and No/100ths (\$7,600.00)-----Dollars,
to us in hand paid at and before the sealing of these presents by
HOWARD A. STONE

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HOWARD A. STONE:

ALL that certain piece, parcel or tract of land in Highland Township, Greenville County, State of South Carolina, containing thirty-eight (38) acres, more or less, and having according to a plat prepared by Jones Engineering Services dated December, 1967, entitled "Property of Howard A. Stone" and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book PPP at page 179, the following metes and bounds:

BEGINNING at a nail and cap in Lindsey Bridge Road in the center of a bridge which spans South Tyger River and running thence with South Tyger River in a Northwesterly direction (having a traverse line as follows: Beginning at an iron pin which is located N. 33-57 E. 40 feet, more or less, from the last mentioned point; thence N. 57-54 W. 198 feet to an iron pin; thence N. 41-38 W. 37 feet to an iron pin which is located 40 feet, more or less, from a point in the center of said River); thence with the line of property now or formerly of Lindsey N. 27-30 E. 726 feet to an iron pin; thence still continuing with the line of said Lindsey property N. 63-30 E. 1135.7 feet to an iron pin; thence with the line of other property of the grantors herein S. 71-05 E. 473.2 feet to a spike in the center line of an old road (formerly a portion of Lindsey Bridge Road now abandoned); thence with the center of said abandoned road as the line having the following courses and distances: S. 25-27 W. 54 feet; thence S. 20-48 E. 100 feet; S. 32-42 E. 100 feet; thence S. 22-37 E. 100 feet; and S. 14-37 E. 100 feet to a point in Lindsey Bridge Road; thence with the center of Lindsey Bridge Road as the line the following courses and distances: S. 3-23 W. 100 feet; thence S. 21-23 W. 100 feet; thence S. 33-02 W. 100 feet; thence S. 35-57 W. 300 feet; thence S. 41-05 W. 112 feet; thence S. 58-00 W. 100 feet; thence S. 73-33 W. 100 feet; thence S. 83-11 W. 100 feet; thence S. 85-21 W. 300 feet; thence S. 88-18 W. 100 feet; thence N. 77-32 W. 100 feet; thence N. 73-57 W. 400 feet; thence S. 83-14 W. 100 feet; thence S. 50-16 W. 100 feet;
