That I, W. L. Woodall

in the State aforesaid,

in consideration of the sum of Ten (\$10.00) ----- DOLLARS, and other considerations,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Garold D. Sloan and Evie M. Sloan and their heirs and assigns forever:

All that piece, parcel or lot of land in the State of South Carolina, Greenville County, Town of Greer, located on the west side of Miller Street, being shown and designated as the lot of W. L. Woodall on a plat of the property of Mrs. Tecora Holland and W. L. Woodall, prepared by H. S. Brockman, Registered Surveyor, dated June 27, 1936, and according to said plat having the following courses and distances, to-wit:

BEGINNING at an iron pin on the property edge of the side walk, which lies on the west side of Miller Street, joint front corner with property now or formerly belonging to Martin Smith; thence with the said side walk, S. 16-57 W. 90 feet to an iron pin, joint front corner of the Mrs. Tecora Holland lot as shown on said plat; thence with the Holland line, N. 73-03 W. 96.8 feet to an iron pin on the line of property now or formerly belonging to Greer High School; thence with the said High School line, N. 21-38 E. 90.45 feet to an iron pin on the line of property now or formerly belonging to Martin Smith; thence with the said Smith line, S. 72-57 E. 89.4 feet to the beginning corner.

This is the same property conveyed to the grantor herein by deed from Mrs. Tecora Holland, dated June 27, 1936, recorded in the R.M.C. Office for Greenville County in Deed Book 187, page 40.

This conveyance is made subject to all easements and rights-of-way of record, as shown on said plat and on the premises.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors, and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

Witness the grantor's(s') hand and seal this 2nd day of January in the year of our Lord One Thousand Nine Hundred and Sixty-eight.

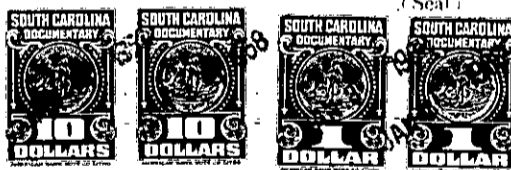
