the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto George W. Vinson and Beate S. Vinson, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 144 of a subdivision known as Colonial Hills, Section No. 3, as shown on a plat thereof prepared by Piedmont Engineers & Architects dated May 7, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 91, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Ardmore Drive, joint front corner of Lots Nos. 143 and 144, and running thence with the joint line of said lots, S. 8-10 E. 167.8 feet to an iron pin at the joint rear corner of Lots Nos. 143 and 144; thence with the rear line of Lot No. 144, N. 73-10 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 144 and 145; thence with the joint line of said lots, N. 11-27 W. 159.4 feet to an iron pin on the southern side of Ardmore Drive, joint front corner of Lots Nos. 144 and 145; thence with the southern side of Ardmore Drive, S. 77-45 W. 90 feet to the point of beginning; being the same conveyed to me by Williams Land Company by deed dated September 14, 1967 and recorded in the R. M. C. Office for Greenville County.
