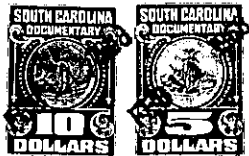
KNOW ALL MEN BY THESE PRESENTS, that We, Edward C. Ligon, Jr. and Lucille D. Ligon,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto James F. Bennett, his Heirs and Assigns forever:

All that certain piece, parcel or lot of land in Butler Township, County of Greenville, State of South Carolina, which is shown on plat of the property of Edward C. Ligon, said plat made by Dalton & Neves, dated March, 1951, and being situate, lying and being on the Southern side of Salters Road (Settlement Road), and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Southern side of Salters Road, which point is 386 feet East of the Southeastern intersection of Salters Road and an unnamed road, and running thence with the common line of the Barnett O'Dell property S. 18-50 E. 416 feet to a corner; thence S. 61-10 W. 208 feet to a corner; thence N. 18-50 W. 416 feet to a point on Salters Road, which point is 178 feet from the Southeastern intersection above mentioned; running thence with Salters Road N. 61-10 E. 208 feet to the point of beginning.
