All that piece, parcel or lot of land in the City and County of Greenville, State of South Carolina, situate, lying and being on the Eastern side of Wembley Road, being known and designated as Lot No. 451, Section D of Gower Estates, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Pages 192 and 193, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Wembley Road, joint front corner of Lots Nos 450 and 451, and running thence N. 63-13 E. 170 feet to an iron pin; thence N. 26-47 W. 90 feet to an iron pin; thence S. 75-00 W. 173 7 feet to an iron pin on Wembley Road, joint front corner of Lots Nos. 451 and 452; thence along Wembley Road S. 26-47 E. 125 feet to an iron pin, the point of beginning.

Office for Greenville County in Mortgage Book 1016, at Page 187, in the original amount of \$22,800.00, the present balance due thereon being \$22,105.99.
