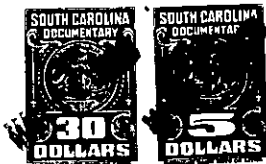
KNOW ALL MEN BY THESE PRESENTS, that I, J. P. Medlock, of Greenville County

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 136 of a subdivision known as Colonial Hills, Section 3 as shown on plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book BBB at Page 91 and having the following metes and bounds, to-wit:
