All of those parcels or lots of land in Oneal Township of Greenville County, South Carolina, located about 2 1/2 miles north of the City of Greer, being shown as Lots Nos. 16, 17 and 18 on a plat designated as Section II of Holliday Hill, property of Agnes M. Holliday Estate, made by John A. Simmons, Surveyor, dated May 4, 1966, recorded in the R.M.C. Office for Greenville County in Plat Book PPP, at page 5. Reference is hereby made to the above mentioned plat for record thereof and complete and detailed descriptions of said lots of land.
