unto C. Columbus Howard, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, at the northwestern corner of the intersection of Buxton Court and Old Dunham Bridge Road and being known and designated as Lot No. 1 on plat of Edgeworth recorded in the R. M. C. Office for Greenville County in Plat Book "LLL", at Page 113, and having, according to a more recent survey prepared by Carolina Engineering and Surveying Co. dated August 17, 1966 the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Buxton Court at the joint front corner of Lots Nos. 1 and 2 and running thence along the joint line of said lots N. 1-58 E. 175.45 feet to an iron pin; thence S. 87-43 E. 80.85 feet to an iron pin on the west side of Old Dunham Bridge Road; thence along the western side of said Road S. 15-20 E. 153.1 feet to an iron pin; thence continuing along said Road S. 5-12 E. 3.8 feet to an iron pin; thence with the curve of the intersection of said Road and Buxton Court (the chord of which is S. 43-19 W.) 33.1 feet to an iron pin on the north side of Buxton Court; thence along the north side of Buxton Court N. 86-02 W. 105 feet, more or less, to the point of beginning.
