All that certain piece, parcel, or lot of land, with the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, and within the corporate limits of the City of Greenville on Biltmore Avenue, being known and designated as a portion of Lot No. 5 as shown on a plat of the property of Roy J.
