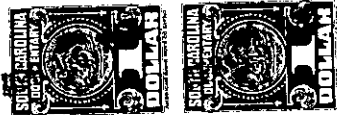

C., in Plat Book KK, Page 107, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Riverview Drive at joint front corner of Lots 25 and 26 and runs thence along the line of Lot 26, N 2-29 W 321.3 feet to an iron pin in the high water mark of Saluda River; thence along the high water mark of Saluda River (the traverse line being N 25-38 E 64.8 feet) to an iron pin; thence S 64-45 E 143.9 feet to an iron pin at the corner of Lot No. 24; thence with the line of Lot No. 24, S 7-32 W 341.5 feet to an iron pin on the North side of Riverview Drive; thence with the curve of Riverview Drive (the chord being N 77-43 W 100 feet) to the beginning corner.
