ALL my undivided interest in and to that certain tract of land situate, lying and being in the County of Greenville, State of South Carolina, containing 42 acres, more or less, in the Pleasant Grove Community south of Greer, said tract being bounded at points by S. C. Highway Number 14 on the east, West Road on the north, and Buncombe Road on the west. This property is shown in the County Auditor's Office as 3 adjoining tracts, as follows: Sheet G 4, Block 2, Lot Number 1 containing 25 acres, more or less; Sheet G 6, Block 2, Lot Number 6 containing 3 acres, more or less; and Sheet 535.1, Block 1, Lot Number 35 containing 14 acres, more or less.

ALSO, ALL my undivided interest in and to all those certain lots situate, lying and being in Greenville County, State of South Carolina, in the Pleasant Grove Community, South of Greer, designated on a plat of Lakeview Heights, recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 19, as Lots Numbers 8, 9, 10, 25, 26, 28, 29, 31, 32, 33, 34, 35, 36, 37, 38, 44, 46, and 47, said lots having the courses and distances shown on said plat.

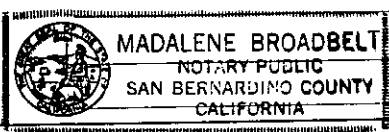
