ALL my undivided interest in and to that certain tract of land situate, lying and being in the County of Greenville, State of South Carolina, containing 42 acres, more or less, in the Pleasant Grove Community south of Greer, said tract being bounded at points by S. C. Highway Number 14 on the east, West Road on the north, and Buncombe Road on the west.
