to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HENRY H. GRIFFIN, his heirs and assigns forever:

ALL my right, title, and interest in and to the following described land;

ALL that piece, parcel, or lot of land, containing approximately 3.13 acres, on Griffin Mill Road, in the County of Greenville, South Carolina, and shown on a plat entitled "Property of Henry H. Griffin" made by Robert Jordan, R.L.S., July 8, 1967; and having, according to said plat, the following metes and bounds:

BEGINNING at a bolt in the center of Griffin Mill Road and running thence with the center of Griffin Mill Road S. 80-47 W. 992.3 feet to an iron pin; thence N. 19-16 W. 36.2 feet to an iron pin; thence N. 61-29 E. 21.53 feet to an iron pin; thence continuing on the same course 31.79 feet to an iron pin; thence continuing on the same course 551.88 feet to an iron pin; thence S. 77-01 E. 462 feet to an iron pin; thence S. 9-13 E. 61.6 feet to the beginning corner.

BEGINNING at a bolt in the center of Griffin Mill Road at a point .14 feet from the southwestern corner of the above described tract and running thence N. 9-13 W. 42.76 feet to an iron pin; thence N. 61-29 E. 31.79 feet to an iron pin; thence S. 9-13 E. 53.25 feet to a bolt in the center of Griffin Mill Road; thence with the center of Griffin Mill Road S. 80-47 W. 30 feet to the beginning corner.
