All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 175 of a subdivision known as Colonial Hills, Section No. 4, as shown on a plat thereof prepared by Piedmont Engineers & Architects, recorded in the R. M. C. Office for Greenville County in Plat Book WWW, at Page 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Heathwood Drive, joint front corner of Lots Nos. 175 and 176, and running thence with the joint line of said lots, S. 0-54 W. 131.05 feet to an iron pin; thence N. 80-15 W. 170 feet to an iron pin on the eastern side of Creighton Street; thence with the eastern side of Creighton Street, N. 9-54 E. 95 feet to an iron pin; thence continuing with Creighton Street as it intersects with Heathwood Drive, N. 52-58 E. 36.5 feet to an iron pin on the southern side of Heathwood Drive; thence with Heathwood Drive, S. 83-49 E. 125 feet to the beginning corner; being the same conveyed to me by Williams Land Company, Inc., same as Williams Land Co., by deed dated January 5, 1968, and recorded in the R.
