a branch; thence a traverse line N. 1-13 W. 439.6 feet; thence N. 14-33 W. 386.7 feet to an Iran pin; thence leaving said branch and running N. 6-35 E. 194.1 feet to aniron pin; thence N. 3-55 E. 236.7 feet to an iron pin; thence N. 40-26 W. 35.1 feet to an iron pin in line of property of Billie C. Patton and Melvin K. Younts; thence with this line S. 60-27 E. 2,381.8 feet to an iron pin in line of property of Carroll J. and Polly G. Chandler; and running thence with that line S. 18-07 W. 150 feet; thence S. 71-30 E. 200 feet to an iron pin on Quillen Avenue; thence with said Quillen Avenue S. 18-12 W. 423.8 feet to an iron pin on Woodvale Avenue; thence with said woodvale Avenue N. 46-12 W 552 feet to a point in property of Blake P. and David H. Garrett; thence with the Garrett line S. 82-28 W. 353.5 feet to an iron pin; thence continuing with the Garrett line S. 12-47 B. 274.4 feet to an iron pin on Woodvale Avenue; thence S. 56-48 W. 225.2 feet to an iron pin; thence S. 51-45 W. 100 feet to an iron pin; thence S. 44-24 W. 548.5 feet to an iron pin, the beginning corner.
