BEGINNING at an iron pin on the Northeasterly side of Gardenia Drive at the joint front corner of Lots 47 and 48 and running thence along the joint line of said lots, N. 37-01 E. 128.4 feet to an iron pin in the center of a 10-foot drainage easement in the rear line of Lot no. 38; thence running along the center of said easement and a portion of Lot No. 38, N. 43-11 W. 80 feet to an iron pin in the rear line of Lot no. 37, joint rear corner of Lots Nos. 48 and 49; thence along the joint line of said lots, S. 39-21 W. 147.5 feet to a point on the Northeasterly side of Gardenia Drive; thence along the Northeasterly side of Gardenia Drive, N. 56-33 E. 85 feet to the point of Beginning.
