



I, WALTER G. ANDERS, KNOW ALL MEN BY THESE PRESENTS, that

in consideration of THREE HUNDRED, FIFTY AND NO/100 (\$350.00) AND ASSUMPTION OF TWO MORTGAGES LISTED BELOW the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release Arthur Nelson and Ola Mae Nelson, their heirs and assigns forever,

ALL that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as a portion of Lots Nos. 5 and 6 of a subdivision known as Meadowbrook Farms as shown on a plat thereof recorded in the RMC Office for Greenville County in Plat Book M, at page 105, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Toler Road at the corner of Lot No. 13, and running thence along Toler Road, S. 57-45 W. 100 feet to an iron pin; thence running along a line through Lots Nos. 5 and 6 N. 39-17 W. 114 to an iron pin; running thence along a line through Lot No. 6 N. 57-45 E. 100 feet to an iron pin in the line of Lot No. 13; running thence along the line of Lot No. 13 S. 39-17 E. 114 feet to the point of beginning; being the same conveyed to me by deed dated September 29, 1967 and recorded in the RMC Office for Greenville County in Deed Volume 829, at page 617.

This conveyance is subject to any restrictions or easements that may appear of record, on the record plat, or on the premises.

This conveyance is subject to a mortgage executed by Charles W. Barnes to C. Douglas Wilson &Company, dated March 24, 1964, in the original sum of Five Thousand, Three Hundred, Fifty and No/100 (\$5,350.00) and recorded in the RMC Office for Greenville County in Mortgage Book 953 at page 127, which mortgage has been assigned to the Greater New York Savings Bank, the balance due on said mortgage being Four Thousand, Six Hundred, Sixty and 18/100 (\$4,660.18) as of this date.

This conveyance is also subject to a mortgage executed by the grantor unto A.M. Bridges in the principal amount of Five Hundred and No/100 (\$500.00) and recorded in the RMC Office for Greenville County in Mortgage Book 1071 at page 79, said mortgage having a current balance of Three Hundred (\$300.00) Dollars.
