to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said BEREAPUBLIC SERVICE DISTRICT COMMISSION, a Body Politic under the laws of South Carolina, Its Successors and Assigns forever:

ALL water lines, mains, valves and appurtenances installed and located in, under or along Hughes Road, located in the County of Greenville, State of South Carolina and specifically including approximately 227 feet - 6" Pipe; 510 feet - 2" Pipe; 1 - 6" Valves; 2 - 2" Valves, as shown on a drawing entitled "J.C.Hughes to Berea Public Service District" attached hereto and made a part of this conveyance.

TOGETHER with all pipes, valves and other mechanical parts and equipment appurtenant to said main and lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water main, pipe lines, and appurtenant equipment.

This deed is to confirm the sale and transfer of the property conveyed hereby originally made on September 13, 1960 by the parties hereto. The original conveyance having been made by the Grantor herein to Berea Water & Sewer District which by appropriate action is now known as Berea Public Service District Commission.
