to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto IRA STANLEY CAMPBELL, JR. and BARBARA ANN C. CAMPBELL:

All that piece, parcel or lot of land situate, lying and being on the Southeastern side of Pennwood Lane near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 7 as shown on a plat of Imperial Hills, prepared by C. C. Jones, dated August, 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 35, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Pennwood Lane at the joint front corner of Lots Nos. 6 and 7 and running thence with the line of Lot No. 6 S. 27-30 E. 153.7 feet to an iron pin in the rear line of Lot No. 4; thence with the rear lines of Lots Nos. 4 and 3 S. 61-46 W. 100.1 feet to an iron pin at the joint rear corner of Lots Nos. 7 and 8; thence with the line of Lot No. 8 N. 27-30 W. 155 feet to an iron pin on the Southeastern side of Pennwood Lane; thence with the Southeastern side of Pennwood Lane N. 62-30 E. 100 feet to the point of beginning.
