C., the receipt whereof being hereby acknowledged, (I) (we) hereby grant unto said City of Greenville, a right-of-way or easement along, over or under (my) (our) property for the purpose of:

Installing and maintaining a sanitary sewer line, said right-of-way to extend 15 feet on each side of the center line during construction and a permanent right-of-way of 5 feet on each side of the center line of said sewer line as installed, and being 125 feet more or less in length.

- 1 - Line to be under ground
- 2 - Trench to be entered and area cleaned
- 3 - \$1.00 per foot. (\$125.00)
- 4 - Right to tap on line.

Together with the right of ingress and egress for the purpose of inspecting and maintaining the same.
