KNOW ALL MEN BY THESE PRESENTS, that I, James H. Barnes,

in consideration of Four Hundred and No/100----- Dollars,  
and assumption of mortgage  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Robert L. Perry, III, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southeastern side of Lawnview Court and being known and designated as Lot No. 10 on Plat of Wm. R. Timmons, Jr. recorded in the R. M. C. Office for Greenville County in Plat Book "XX", at Page 9, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Lawnview Court at the joint front corner of Lots Nos. 10 and 11 and running thence along the joint line of said lots S. 69-07 E, 159.8 feet to an iron pin; thence S. 27-22 W, 103.8 feet to an iron pin; thence along the joint line of Lots Nos. 9 and 10 N, 59-12 W, 150.8 feet to an iron pin on the southeastern side of Lawnview Court; thence along said Court N. 25-50 E, 31.3 feet to an iron pin; thence continuing along said Court N. 20-53 E, 54 feet to the point of beginning.

This conveyance is subject to such restrictions, easements or rights of way as may appear of record.
