

Dresback and Lee V. Dresback, Their Heirs and Assigns, Forever:

ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Northwesterly side of Woodfern Circle (formerly Hampton Circle) near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot No. 17 on plat of Property of Talmer Cordell, as recorded in the RMC Office for Greenville County, South Carolina in Plat Book AA, Page 33, and having, according to said plat, the following metes and bounds,

BEGINNING at an iron pin on the Northwesterly side of Woodfern Circle joint front corner of Lots 17 and 18 and running thence along the joint line of said Lots, N 47-00 W 205 feet to an iron pin on the Southeasterly side of Pitts Street; thence along the Southeasterly side of Pitts Street, N 43-00 E 85 feet to an iron pin, joint rear corner of Lots 16 and 17; thence along the joint line of said lots, S 47-00 E, 205 feet to an iron pin on the Northwesterly side of Woodfern Circle; thence along the Northwesterly side of Woodfern Circle, S 43-00 W 85 feet to the point of beginning.
