the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto CATHERINE D. MUNDY,

All that piece, parcel or lot of land, situate, lying and being on the easterly side of Cashmere Drive near the City of Greenville, South Carolina, being known and designated as Lot No. 49 according to plat of Pine Hill Village prepared by R. K. Campbell, R.S. July 9, 1962 as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ at page 169 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the easterly side of Cashmere Drive at joint front corner of Lots 48 and 49 and running thence along the joint line of the said lots N. 74-14 E. 125 feet to an iron pin on the rear line of lot 200; thence S. 15-46 E. 72 feet to an iron pin at the joint rear corner of Lots 48 & 49; thence along the joint line of the said lots S. 74-14 W. 125 feet to an iron pin on the easterly side of Cashmere Drive; thence along said Cashmere Drive N. 15-46 W. 72 feet to the point of beginning.

The above described property is subject to existing rights of way, easements, reservations and restrictions, recorded in the RMC Office in Deed vol. 665 at page 465.
