All that certain piece, parcel or lot of land in the City and County of Greenville, State of South Carolina situate, lying and being on the western side of Pimlico Road and being known and designated as a major portion of Lot No. 105 on plat of Section A of Gower Estates Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "QQ", at Pages 146 and 147 and having, according to said plat, the following metes and bounds, to-wit:
