GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, Walter J. Davis, of the County of Greenville, State of South Carolina (temporarily residing in the State of Alaska) in consideration of the sum of One Dollar (\$1.00) and other valuable considerations to me in hand paid, have made, constituted and appointed, and by these presents do make, constitute and appoint Nevada J. Davis my true and lawful attorney-in-fact to represent and act for me in my name and stead in all matters of business in which I am interested and in all matters pertaining to my property, real or personal, which I now own or in which I have an interest, or which I may hereafter acquire, including the right, power and authority to issue in my name and stead check or checks on any bank account standing in my name and to withdraw said funds or any portion thereof for such purpose as said attorney-in-fact may desire, and to endorse or cash checks or other evidences of indebtedness due me and to deposit the same in said bank account; to purchase any goods, shares of stock or other commodity on such account and for such price and in such amount as in her sole discretion may be proper and with full power and authority to sell again for my benefit and on my account for any price whatsoever; to sell, mortgage, exchange or dispose of any real estate of which I am now seized or possessed, or in which I might have any interest, to any person or persons, for any price, or in any manner whatsoever, and for these purposes to execute any deed or deeds, lease or leases, or other assurance or assurances, with general covenants whatsoever as she may deem expedient; to purchase any real estate on my account in fee simple, or otherwise, at any price or any exchange whatsoever and for these purposes to receive, confirm, make and execute any contracts, deeds, conveyances, notes, mortgages or other instruments whatsoever; to compound for any debts, dues or other demands owing, or which may be hereafter owing to me and to take less than the whole or otherwise to agree for the same, in such manner and on such terms as she in her discretion, may deem proper; and for all or any of the foregoing purposes, to make and execute any releases, compromises, compositions, agreements of contracts, by deed or otherwise, in her opinion necessary and expedient in the premises, and generally to do and perform all matters and things, transact all business, make, execute and acknowledge all contracts, orders, deeds, mortgages, notes, satisfactions of mortgages, leases and assignments of the same, and all other writings which may be requisite or proper to effectuate any or all of the foregoing matters or any other matter with the same validity and to all intents and purposes as I could if personally present and I do hereby ratify and confirm whatsoever my said attorney-in-fact shall and may do, by virtue hereof, in the premises.
