BEGINNING at an iron pin on the eastern side of S. C. Highway No. 14 at the corner of property owned by Bryson Estate and running thence N. 59-21 E. 1140.4 feet to an iron pin; thence N. 72-25 E. 438.9 feet to an iron pin; thence N. 7-45 E. 135.3 feet to an iron pin; thence N. 78-17 E. 525.5 feet to an iron pin; thence N. 77-14 E. 731.7 feet to an iron pin; thence S. 51-06 W. 1405.4 feet to an iron pin; thence S. 55-29 W. 1369.8 feet to an iron pin on the eastern side of S. C. Highway No. 14; thence along the eastern side of said Highway N. 37-58 W. 686.4 feet to the point of beginning. TOGETHER with a 25-foot easement for a railroad spur which shall run from the center line of the C & WC Railroad (also known as ACL Railroad) across the property conveyed by Simpsonville Investors, Inc. to Woodside Mills by deed recorded in Deed Book 787, at Page 621, said easement to run in an easterly direction crossing S. C. Highway No. 14 along such route as the grantee herein shall hereafter select. The initial placing of the spur line track shall permanently locate the center line of said easement, which shall remain in existence so long as said railroad spur shall remain so located and in operation. The said easement being the same easement reserved by Simpsonville Investors, Inc. in its deed to Woodside Mills above referred to.
