All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the southerly side of Wayne Drive, being shown and designated as Lot No. 55, on plat of Section II, Edwards Forest, recorded in the RMC Office for Greenville County, S. C., in Plat Book "RR", at Page 20, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly side of Wayne Drive, joint front corner of Lots Nos. 55 and 56, and running thence with the joint line of said lots S. 33-15 E. 198.6 feet to an iron pin on Bridgewood Avenue; thence with said Avenue on a curve, the chord of which is S. 84-21 W. 99.8 feet to a bend; thence continuing with said Avenue S. 66-45 W. 42.1 feet to a curve at the intersection of Bridgewood Avenue and Randy Drive; thence on a curve, the chord of which is N. 67-54 W. 35.2 feet to a point on Randy Drive; thence with Randy Drive N. 22-32 W. 93.4 feet to a curve at the intersection of Randy Drive and Wayne Drive; thence on a curve, the chord of which is N. 17-08 E. 38.5 feet to a point on Wayne Drive; thence with Wayne Drive N. 56-45 E. 103.1 feet to the point of BEGINNING..

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record and on the ground.

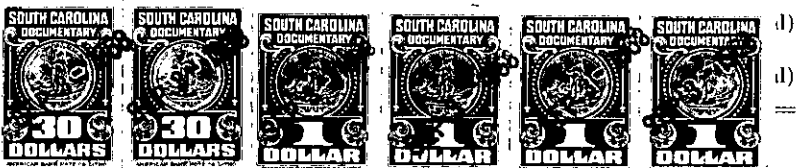
