All of those pieces, parcels or lots of land located on Wood Heights Avenue, County of Greenville, State of South Carolina, shown and designated as Lots Nos. 3 ~~AND 4~~ on a plat of Edwards Forest, Section Three, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book BBB at Page 99, and having, according to said plat, the following metes and bounds, to-wit:
