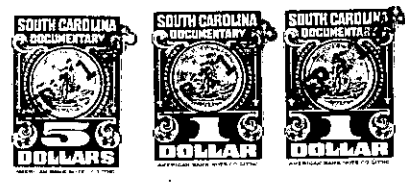

EDWARD C. CORN AND BOBBIE R. CORN, THEIR HEIRS AND ASSIGNS, FOREVER:

All those certain pieces, parcels, or lots of land in the County of Greenville, State of South Carolina, on the northerly side of Tamarack Trail, being shown and designated as Lot No. 16 and the westerly portion of Lot No. 17, on plat of Fontana Forest, recorded in the RMC Office for Greenville County, S. C., in Plat Book "YY", at Page 171, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of Tamarack Trail, joint front corner of Lots Nos. 15 and 16, and running thence with the joint line of said lots N. 50-04 W. 228.2 feet to an iron pin; running thence N. 72-23 E. 169.8 feet to an iron pin, joint rear corner Lots Nos. 16 and 17; thence continuing N. 72-23 E. 60 feet to an iron pin in rear line of Lot No. 17; thence on a new line through Lot No. 17 S. 22-38 E. 175.8 feet to a point on the northerly side of Tamarack Trail; thence with said Trail S. 72-23 W. 45 feet to an iron pin, joint front corner of Lots Nos. 16 and 17; thence continuing with said Trail, on a curve, S. 58-57 W. 80 feet to the point of BEGINNING.

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground, especially a Duke Power Company easement affecting the northwesterly corner of Lot No. 16.
