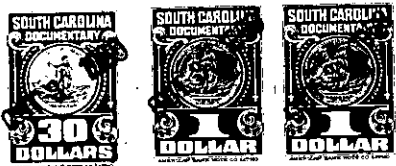
KNOW ALL MEN BY THESE PRESENTS, that Roger D. Hawkins and Rebecca D. Hawkins -----
