in consideration of Sixteen Thousand Nine Hundred Fifty and No/100--(\$16,950.00) Dollars

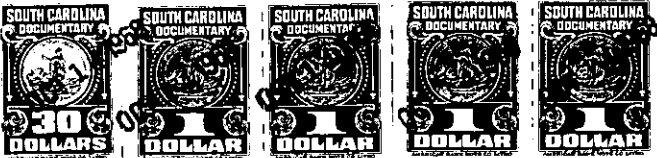
