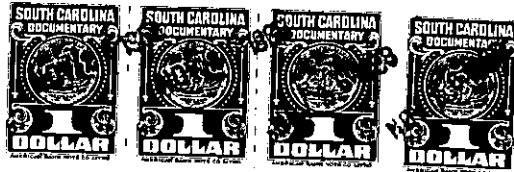
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the Town of Mauldin, and being known and designated as Lot Number 11 of a subdivision known as Glendale II, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book 000 at Page 55, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Hickory Lane at the joint front corner of Lots 10 and 11 and running thence with the Northern side of Hickory Lane N 69-22 E 95 feet to a point at the joint front corner of Lots 11 and 12; thence N 17-25 W approximately 284.6 feet to a point in a branch at the joint rear corner of Lots 11 and 12; thence with said branch as a line approximately S 41-48 W approximately 137.1 feet to a point in said branch at the joint rear corner of Lots 10 and 11; thence S 23-23 E approximately 221 feet to a point on the Northern side of Hickory Lane at the point of BEGINNING.
