KNOW ALL MEN BY THESE PRESENTS, that I, ELFRIEDE KRSTOVIC,

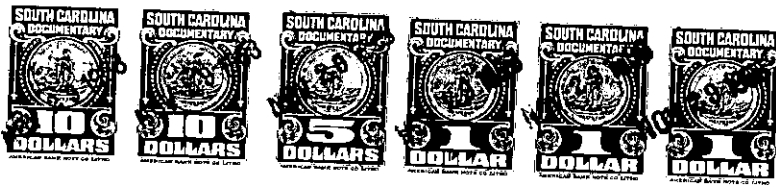
in consideration of Thirteen Thousand Seven Hundred and No/100 (\$13,700.00)-----Dollars,
