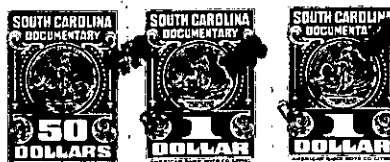
KNOW ALL MEN BY THESE PRESENTS, that Kazimira J. Pickett -----
