in consideration of One Thousand Five Hundred and 00/100 (\$1,500.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Lane Y. Ragsdale, his heirs and assigns, forever:

"ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on waters of Mathers Creek, in the "Sunset Valley Subdivision", Block A, being known and designated as Lot No. 5, on plat of John C. Smith, Surveyor, dated July 1960 and being more fully described according to said plat as follows, to-wit: BEGINNING at an iron pin on Ragsdale Drive, common corner of Lots 4 and 5, and the Northeastern corner of the tract herein described, thence South 67-44 East 149 feet with line of Lot 4 to a point in Mathers Creek; thence with creek South 33-57 West 166.7 feet to a point; thence, leaving creek and crossing iron pin on bank, North 42-59 West 173 feet to a point on Ragsdale Drive; thence North 47-01 East 100 feet to the point of BEGINNING; this being a portion of the "Old Tom Clark Place" conveyed to the grantor by deed of Rachel Howard."

The grantee, his heirs and assigns, by the acceptance of this conveyance are required to install any septic tank or other sewage disposal in accordance with the regulations of the State Board of Health, subject to inspection by local public health authorities.
