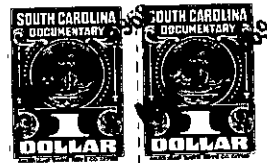
in consideration of ---Seven Hundred, Fifty and No/100 (\$750.00)----- Dollars,

All that piece, parcel or lot of land situate, lying and being on the southerly side of Lincoln Road in Chick Springs Township, Greenville County, South Carolina, being known and designated as Lot No. 35 according to plat of Section II of the property of Lily McC. Loftis prepared by Terry T. Dill, October 3, 1959 as revised September 27, 1960 as recorded in the R.M.C.
