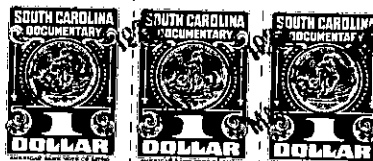
KNOW ALL MEN BY THESE PRESENTS, that we, Pearl S. Guest and Edna S. Guest
