in consideration of One Thousand Five Hundred (\$1,500.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Carl W. Henry and Martha A. Henry, their heirs and assigns, forever:

"ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on waters of Mathers Creek, in the "Sunset Valley Subdivision", Block A, being known and designated as Lot No. 11, on plat of John C. Smith, Surveyor, dated July 1960 and being more fully described according to said plat as follows, to-wit: BEGINNING at an iron pin on Ragsdale Drive, common corner of Lots 11 and 12, and to the Northwestern corner of lot herein described, thence North 28-21 East 100 feet with road to an iron pin; thence South 61-39 East 150 feet, crossing iron pin, to a point in center of Mathers Creek; thence South 32-55 West 100.3 feet with center of creek to a point; thence, leaving creek and crossing iron pin on bank North 61-39 West 142 feet to the point of beginning on Ragsdale Drive; this being a portion of the "Old Tom Clark Place" conveyed to the grantor by deed of Rachel Howard."

The grantees, their heirs and assigns, by the acceptance of this conveyance are required to install any septic tank or other sewage disposal in accordance with the regulations of the State Board of Health, subject to inspection by local public health authorities.
