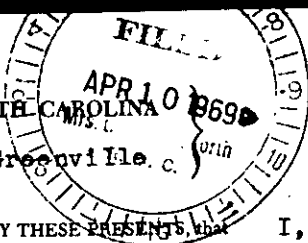

KNOW ALL MEN BY THESE PRESENTS, that I, Aubrey C. Fore, Executrix of the Estate of M. W. Fore, deceased,

in consideration of - - Seven Hundred Ninety-five and No/100 (\$795.00) - - - - - Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

James G. Patey and Bess G. Patey, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in the County and State aforesaid, being known and designated as Lot No. 120 Jacqueline Road as shown on a Plat of Golden Grove Estates by Dalton & Neves, Engineers, dated September, 1965, recorded in the R.M.C. Office for Greenville County in Plat Book JJJ at Page 97, and having according to said Plat the following descriptions, to-wit:

BEGINNING on Jacqueline Road at an iron pin at joint front corners of Lots 119 and 120 and running thence 190 feet with the line of said Road to an iron pin at joint front corners of lots 120 and 104; running thence 113.2 feet with the side line of lot 104 to an iron pin at joint rear corners of lots 104, 105 and 120; running thence 160 feet with the rear line of lots 105 and 106 to an iron pin at joint rear corners of lots 106, 119 and 120; running thence 146 feet with the side line of lot 119 to the iron pin on Jacqueline Road at joint front corners of lots 119 and 120, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; the building line setback is 100 feet for lots 20 and 21; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes, only, except lots 43, 44 and 75.

THIS conveyance is subject to all easements and rights of way of record.
