KNOW ALL MEN BY THESE PRESENTS, that I, Kenneth T. Black, and Marcia M. Black

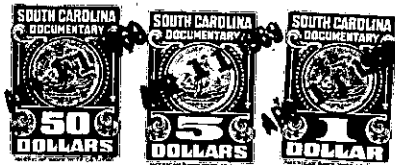
in consideration of Twenty-Seven Thousand Six Hundred and No/100 (\$27,600.00)-----Dollars,

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as "Property of Richard D. Rollins and Loretta M. Rollins" on a plat dated April 7, 1969, prepared by R. B.
