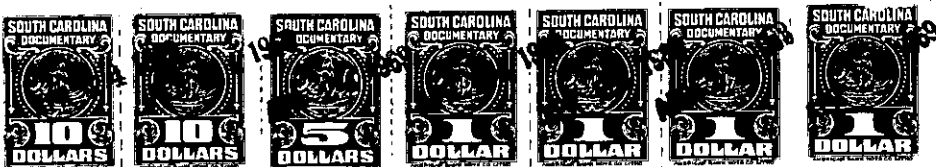
KNOW ALL MEN BY THESE PRESENTS, that RALPH G. LAND
