KNOW ALL MEN BY THESE PRESENTS, that I, T. Walter Brashier

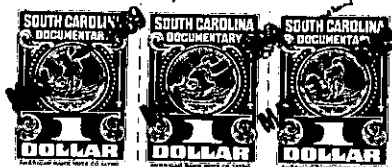
in consideration of Twelve Hundred & No/100 (\$1200.00)----- Dollars,
